Bird Song Trust is a recently-established family foundation, awarding grants totalling between £2.5m and £4m a year (with room to grow), focused on two programme areas:

1. Deprivation in the UK

Our founders are motivated by a strong Christian faith, and we want to see thriving families equipped to deal with challenges, breaking cycles of deprivation. We do this by funding organisations that support and strengthen families, tackle homelessness and prepare young people for a valuable role in society. We intend that at least half of the projects in this programme area are delivered by Christian organisations or in partnership with churches. Recent examples of grantees include ThisIsGrowTH; the Moses Project; Hammersmith and Fulham Food Bank; Clean Slate Solutions.

2. Eating Disorders (Research and Services)

We want to build a greater understanding of these conditions, of the triggers and causes, resulting in more effective treatment programmes. We do this by funding research, campaigns, and career development of researchers in the UK. We also want to increase support for people living with eating disorders and those who care for them and we do this by funding Stichting Kiem in the Netherlands.

Because the Trust is fully funded, we can fund projects that are at the cutting edge, or in areas other funders aren't focusing on. Our staff team are in regular contact with the family behind the Trust, and aim to build deep relationships with our charities and the people behind them.

Job title: Grants Manager

Reporting to: Director

Location: Hybrid - our team is based in our Canary Wharf office at least 50% of the time.

Working hours: We are open to candidates who are available for 4-5 days per week.

Salary: £42,000-£53,000 pro-rata

Annual leave: 25 days holiday per year, plus bank holidays, with an additional 3 days off (pro rata)

Role summary

This role will help us to take the Trust into its next stage of implementation and growth. Reporting to the Director, you will act as a second-in-command, managing our grants across the portfolio but with a focus on the deprivation programme. You will have support from a Grants Officer who oversees the Eating Disorders programme areas. You will carry out research into organisations at the front line in the UK, monitor our grants and coordinate the applications process.

2Job description



Duties

- Supporting the Director in developing our grant making strategy across both programme areas.
- Researching applications and potential partners due diligence checks, assessing applications, and making recommendations
- Monitoring existing grants. Making recommendations for continuation or termination.
- Preparing grant letters and coordinating e-signing.
- Liaising with our bookkeepers and accountants to support the production of Management Information and Annual Accounts
- Researching and drafting policies and procedures, including advising grantees on their own policies.
- Producing and collating board papers and presentations, including taking minutes of board meetings and following up on actions.
- Keeping accurate records, complying with Data Protection.
- Developing and maintaining in-house knowledge of the state of the sector, and trends in philanthropy.
- Supervising the Officer's work, and deputising for the Director
- Promoting the Trust's founding Christian ethos, representing the Trust at events, supporting the ethos of Christian grantees.
- Other duties as required in a small team, including occasional attendance at evening meetings and travel in the UK.




Essential


